In relation to my participation in the sporting event Race Around Poland 2024 and the WUCA World Ultra-Cycling Championships (the "Race") and in view of the contents of the Race Regulations (the "Regulations"), I hereby declare as follows:

### **STATEMENT OF HAVING READ AND ACCEPTED THE RULES AND REGULATIONS**

I hereby declare that I have read the contents of the Rules and Regulations and the appendices forming an integral part thereof, in particular the provisions concerning my consent to the processing of the personal data I have voluntarily provided, and the use of my image, including by the WORLD ULTRA CYCLING ASSOCIATION, 123 Main Street, Colorado Springs, CO 12345, USA, as well as the regulations defining my rights and obligations arising from my participation in the Race, and I hereby declare my consent to them. I further declare that I have received from the Organiser and have familiarised myself with the current list of Co-organisers and Race Partners and have no objections to it.

### **DECLARATION OF ASSUMPTION OF RISK AND RELEASE FROM LIABILITY RACE AROUND POLAND - TEAM MEMBER**

In consideration of my admission as a team member supporting a participant to take part in the Race Around Poland cycling race, which takes place over a route of approximately 4000 km, in open traffic through varied terrain, during weather conditions unknown at the time of its commencement, and is a continuous and multi-day event, being fully aware that:

- i. Cycling is a type of physical activity, the practice of which inevitably involves the risk of injury, injury and even death as a result of an accident, requiring strenuous effort and concentration, including as a result of circumstances relating to health, equipment or equipment failures, a failure to exercise due care and caution by the participant, or other persons, including volunteers and other persons involved in the organisation of the Race, a breach of traffic law, or other regulations, including by persons other than the participant, and participation in a cycling race such as Race Around Poland makes these risks even greater;

- ii. I, as a member of the team supporting a participant who is a cyclist, have a special responsibility and duty of care to ensure the safety of the participant while riding and while resting, to prevent dangerous situations on the road and to react to incidents that may occur during the Race;
- iii. The route of the Race is routed outside the closed cycling track and the Organiser has no possibility of closing it to traffic for its duration. During the Race I will be participating in normal traffic, with cars and other vehicles not taking part in the event, as well as pedestrians, which means that I will bear the risks involved, including those arising from incidents beyond my control;
- iv. the Organiser has made every effort to devise the rules for participation in the Race in such a way as to enable me to participate as safely as possible, however, to the extent that my actions or omissions depend on my actions or omissions, the complete responsibility for the safety of the participant rests with me, as well as for my own safety and for the possible consequences of my actions;

I hereby declare completely voluntarily and knowingly that:

- i. I assume the risk and indemnify, to the maximum extent permitted by law, the Organiser, and all persons and entities cooperating with the Organiser during the organisation of the Race, including volunteers, partners and sponsors (hereinafter "Indemnitees"), for any and all events in connection with my action in the Race as a member of the participant's support team;
- ii. The above exemption also applies to incidents occurring before, during and after the Race insofar as they were in connection with the Race;
- iii. In view of the foregoing, I shall not assert against any Indemnitees any claim, whether of a pecuniary or non-pecuniary nature.

**TEAM MEMBER'S DECLARATION OF HEALTH STATUS AND LACK OF HEALTH CONTRAINDICATIONS TO TAKE PART IN THE RACE AROUND POLAND**

Applying to participate in the Race Around Poland 4000 km cycling race as a member of the team supporting a participant, being aware that:

- i. The cycling race over a route of approximately 4000 km, in open traffic, through varied terrain, including significant altitude, of a continuous and multi-day nature, requires extreme effort from the participant and the team members supporting the participant, and involves above-average risks of adverse health effects in all forms, regardless of prior fitness preparation, as well as, among other things, risks due to reduced concentration on the move;
- ii. The nature of the tasks of the team member supporting the participant results in his/her physical or mental incapacity affecting the level of safety of the participant, other team members or third parties;

I, the undersigned, declare that I have had appropriate medical care and regular examinations which show that I remain fit to participate in cycling races as a member of the support team, am aware of my health condition and have no health contraindications preventing me from participating safely in the Race.

I enter the Race at my own risk. I have read the Rules and Regulations and undertake to abide by them and follow the instructions of the Organiser.

I acknowledge that the Organiser shall not be liable for any injury or other detriment to my health suffered by me or any other person on my account during the Race, nor for any detrimental effect my participation in the Race may have on my health.
